Please join me in saying thank you to Morrie Stevens for his efforts as a long-term board member.



## July 14, 2012—Membership Meeting Minutes

**PRESIDENT'S OPENING:** The LMPOA Purpose Statement was shared with the membership.

**TREASURER'S REPORT:** Spencer reported a balance in the bank account of \$6,565.43.

<u>SECRETARY'S REPORT:</u> Dodge summarized minutes from the May 19, 2012 special membership meeting held for the primary purpose of ratifying changes to the association's bylaws. Minutes were approved as submitted.

**MEMBERSHIP:** Spencer reported 215 paid memberships.

### **OLD BUSINESS:**

- ELECTIONS:
  - Spencer reported that Hal Helterhoff had been appointed in May to fulfill the term of a board member who has resigned. Motion was made and seconded to ratify the appointment. MOTION PASSED.
  - Roe reported for the nominating committee (Roe & Porter) four nominations for three board seats. The nominees are Bob Wilson, Chuck Spencer, Doug Dodge, and Morrie Stevens. Hearing no nominations from the floor Roe moved nominations be closed. MOTION PASSED.
  - Ballots were distributed, collected, and tallied by Roe and Wojcik. Subsequently, Roe reported Dodge, Spencer, and Wilson were elected for three year terms.
- EVENTS:
  - FISHING DERBY: Hannan reported a successful annual program. We had increased participation and we were in the financial plus column due to several very generous donations. A special thanks to Roger Wilcox for his donation of hot dogs and soda.
  - DINNER SHOW: Hannan also reported over 100 people enjoyed dinner and a show at the Officers Club at Camp Grayling. The entertainment "Broadway On The Lake" by the Michigan Opera Theater Ensemble was exceptional.
  - BOAT PARADE: Dodge reported the Boat Parade on the 4<sup>th</sup> of July was well received and participation was very good. A special thanks to Judge Alton Davis who led the judging team.

- MILFOIL REMEDIATION: Michalik reported that the efforts of Gary McConnell, Len & Diane Bingert, Ken Michalik resulted in locating, mapping, and treating the largest Eurasian Milfoil "hot spots" in the lake. Treatment of up to 12 acres of lake bottom took place on June 5, 2012. Michalik also reported she will be looking into a piece of equipment used by other lakes to vacuum up the milfoil weeds and thereby subvert the use of harsh chemicals.
- LAKE VEGETATION MAPPING; Michalik reported that with the help of Michigan State University, volunteers will be trained to identify all types of vegetation and map the existence in the lake. Comparing these data with similar mapping results from 2002 will help us maintain the health of our lake and its inhabitants.
- LAKE MARGRETHE FOUNDATION: No report. Member comments: Bob Young encouraged LMPOA members to participate in Lake Margrethe Foundation. This fund is only 14 years old, but has raised more than \$100,000 and only the interest is spent from the fund. This fund is the one that helps fund the Milfoil project.
- LAKE WATER LEVEL: See chart on page 1.
- E-COLI TESTING: No report. Annual samples will be taken in August.



Eurasian water milfoil is a submersed aquatic plant native to Europe, Asia, and northern Africa. Like most of the native milfoils, the Eurasian variety has slender stems curled by submersed feathery leaves. The stems of Eurasian water milfoil tend to be limp, and may show a pinkish-red color. The 4-petaled, pink flowers of Eurasian water milfoil are located on a spike that rises a few inches out of the water. The leaves are typically divided into 12 or more pairs of threadlike leaflets. The most common native water milfoils tend to have whitish or brownish stems, and leaves that divide into fewer than 10 pairs of leaflets. They are distinguished by the presence of many small bladders on the leaves, which serve to trap and digest small aquatic insects.



### Michigan DNR Report (Excerpts)

Lake Margrethe is a 1,922 acre lake in western Crawford County. It is the largest lake in the county. Lake Margrethe lies in the Manistee River watershed having Portage Creek as an outlet, which joins the Manistee River approximately seven miles downstream from where it flows out of the lake. There is a lake level control structure on the Portage Creek outflow. The lake level has been set by Circuit Court order. Lake Margrethe is a mesotrophic\* lake with a maximum depth of 65 feet. The northern lobes of the lake are relatively shallow; the central portion of the lake holding the deeper water. The Lake Margrethe Property Owners Association is the primary citizen-based group for the lake. LMPOA was incorporated in 1968 and has been very involved in lake management since then.

Much of western and southern shores of Lake Margrethe are owned by the Nation Guard as part of the Camp Grayling, the nation's largest National Guard training facility, encompassing about 147,000 acres.

Lake Margrethe has some problems with Eurasian Milfoil prompting treatment by 2,4-D, as permitted by the MDEQ.

Eurasian Milfoil is an extremely aggressive exotic aquatic macrophyt that can crowd out native aquatic plants and cause problems for boaters, anglers, and fish populations.

\*Mesotrophic lakes contain a narrow range of nutrients, principally phosphate and nitrate, the concentrations of which are considered to be neither high nor low.
